



In-Home Display Lease Agreement

The undersigned member (Applicant) requests Glacier Electric Cooperative (Cooperative) furnish an In-Home Display (IHD) and hereby agrees to take and pay for the IHD in accordance with and subject to this agreement. For supplying and maintaining the IHD, the Applicant hereby grants to the Cooperative rights to install, operate, and maintain upon or remove from the premises located at the service address below, its IHD, together with the rights of ingress and egress to and from said facilities. The IHD shall remain at all times the property of the Cooperative. At the time Applicant installs the IHD, this application becomes a contract for the length of time agreed to by both parties. Service under this agreement shall be terminated upon written notice by either party to the other. Should the applicant discontinue service hereunder, all unpaid charges shall immediately become due and payable.

By signing this application, the Applicant acknowledges that the Cooperative disclaims any and all warranties, express or implied, concerning the IHD pursuant to this application. Cooperative shall be held harmless in connection with the operation of the IHD pursuant to this application. In the event the service to the facilities should be interrupted or fail for any reason, the Cooperative's sole obligation shall be to repair or replace IHD pursuant to this application within a reasonable time after actual notice of the condition is received by the Cooperative and such interruption or failure shall not constitute a breach of this contract, nor shall the Cooperative, its affiliates, officers, directors, or employees, be liable to the Applicant or to third parties for damages by reason of such interruption or failure.

The Applicant agrees to pay to the Cooperative a deposit of \$50 for the use of the equipment. The Applicant also agrees to pay a \$5.00 monthly lease charge for the equipment.

- If the applicant terminates electric service with the Cooperative they may return their IHD within thirty (30) days of termination of service to receive their \$50 deposit (less any unpaid balance from the account).
- If the applicants returns their IHD after more than thirty (30) days from termination of service the Cooperative will return \$25 of the deposit.

This agreement supersedes all previous agreements or representations, either written or oral, therefore in effect between the Cooperative and the Applicant, made in respect to matters herein contained, and when signed on behalf of both parties, this application and agreement constitutes the entire agreement between the Cooperative and the applicant.
